

## Safety Rules Due to COVID 19 (SARS-COV-2)

Rules for the purchase and use of the TATRY SUPER SKI passes during the period of implementation of the sanitary guidelines for the ski industry in relation to the prevention, counteraction and combating of COVID-19 "Safety Rules Due to COVID-19"

- 1. All persons entering the ski area are required to read and follow these COVID-19 Safety Rules.
- 2. The regulations for using the TATRY SUPER SKI Pass are valid, taking into account the Safety Rules Due to COVID-19.
- 3. It shall be clarified that the use of the infrastructure of the ski resort, including means of transport (lifts, gondola, etc.), as well as the ski runs, is allowed at a given time under the terms of the applicable legal regulations, guidelines and recommendations of the relevant ministries and the Main Sanitary Inspectorate for the ski industry. The relevant legal regulations, guidelines and recommendations of the competent ministries and the Main Sanitary Inspectorate also define the rules of the operation of ski equipment rentals, ski schools and catering service, as long as running such business activities has not been prohibited by law at a given time.
- 4. Due to the fact that guidelines and recommendations given above in the item No. 3 are (can be) published and changed on an ongoing basis by the competent state institutions (e.g. because of the so-called mitigation or aggravation of restrictions) in relation to epidemiological situation in Poland at a given time, the ski resort will make every effort to present immediately, after publishing these guidelines and recommendations, on the website https://tatrysuperski.pl/covid, and at the entrance to the ski resort or at the ticket offices (this information will also be available at the ski resort call centre).
- 5. A ski resort may provide for additional sanitary/safety restrictions than those presented in the guidelines and recommendations referred to in the item No. 3 above, whereas in such case it will present them in the way specified in the item No. 4 above (along with the expected duration of their validity, and if such an indication is not provided, it will mean that these restrictions will remain in force until further notice), and these additional restrictions will be justified by preventing, counteracting and combating COVID-19 and protecting the health of people in the ski resort.

- 6. A person who intends to use the infrastructure of the ski resort on a given day should read the information relating to the above-mentioned recommendations, guidelines and restrictions the day before (if he or she intends to do so on the day of purchasing the skipass, he or she should do so before purchasing the skipass) and follow them.
- 7. The ski resort in the manner provided for by the law, by the above-given recommendations and guidelines, and by the contract concluded with the client, will be entitled to verify and implement the Safety Rules related to COVID-19. The client's lack of consent to the above verification, provided that it requires the client's consent in the light of the law, may justify, for the sake of health protection of other persons, the refusal to provide services by the ski resort. The refusal to provide the service by the ski resort is also possible in objectively justified case, i.e. due to the protection of the health of other people, consisting in the appearance of disturbing symptoms at the client, suggesting infection with the SARS-CoV-2 virus (coronavirus) of the client, unless in a manner provided for by law it will be clarified that these symptoms are not related to the virus described above.
- 8. The ski resort explains that the obligation to cover one's mouth and nose, as well as to keep the proper distance, applies to the rules resulting from the regulations in force at the time, including the regulations of the Council of Ministers on the establishment of certain restrictions, orders and prohibitions in relation to the epidemic outbreak.
- 9. Bearing in mind the above-mentioned and the Terms of Use of the TATRY SUPER SKI Pass, it shall be explained that in the event that the person using the Pass does not fulfill the obligation of covering the mouth and nose, provided for by law (unless the person is not obliged to do so pursuant to the provisions of the law), the Term Permissions on the person's Card for the protection of health of other persons, after such a case is identified, will be temporarily locked until such violation ceases. The Pass can be unlocked in designated areas.
- 10. The ski resort explains that the rules contained in this document also apply to persons who enter the ski resort and do not use the TATRY SUPER SKI Pass.
- 11. This COVID-19 Safety Rules are effective from December 5, 2020 until further notice.
